Introduction

The MIAX Member Firm Portal ("MFP") is an internet-facing portal which provides self-service functions to member firms for the following exchanges:

- MIAX Options Exchange
- MIAX Pearl Options Exchange
- MIAX Emerald Options Exchange
- MIAX Sapphire Options Exchange
- MIAX Pearl Equities Exchange

Users can log into the MFP at all times except during pre-announced maintenance windows

Users can be permissioned in one of the following two access levels per exchange.

- Read Only Users are able to view information contained within the pages they receive access for
- Read/Write Access Users are able to view information, and request changes to certain fields/values within the pages they receive access for

Individuals requesting MFP access must be authorized to act on behalf of their organization. A new account will be provided a temporary password before being asked to set a permanent password and security questions following initial login. All accounts require dual authentication through a password and separate token input which is generated upon each login. Accounts that are inactive for more than two weeks will require a password reset.

Features Included in the MFP

For All MIAX Exchanges:

- Ability to view current connectivity and services
- Ability to view all market making assignments and make updates (excluding Primary Lead Market Maker assignments)
- Ability to view current risk protection settings and request configuration changes
- Ability to download latest request forms (except for Regulatory forms, which can be found on the <u>Options Regulatory Forms</u> and <u>Equities Regulatory Forms</u> pages on our website)

For the MIAX Options Exchanges:

- Ability to view and request changes for current session notification configurations
- Ability to view trades across all MIAX exchanges and edit non-material trade details

For the MIAX Pearl Equities Exchange:

- Ability to view current session notification settings
- Ability to change current session and MPID risk configurations, which are effective immediately (if within applicable standards)
- Ability to view all orders and cancel individual open orders

Breakdown of Available Functions

Dashboard Page

• Contains a tutorial of all the latest updates to the MFP

Connectivity Page

- Users can view their firm's currently subscribed unicast interfaces and multicast feeds, as well as the "Activated Date" for each service
- The MFP identifies the Transit IP, Cross Connect Type, and LOA for each service

Market Maker Assignments Page

- With Read Only Access, users can view all listed symbols and check the current assignment status for their firm or a specific MPID, as well as assignment history for each symbol
- With Write Access, users can make changes to assignment statuses in a given symbol
 - For MIAX and MIAX Emerald Options, Write Access also provides users the ability to change their role between Lead Market Maker ("LMM") and Registered Market Maker ("RMM") in any assigned symbol where they are not the Primary Lead Market Maker ("PLMM"). The deadline to make changes effective for the next trading day is 6:00 PM ET.
 - For MIAX Pearl Equities, Write Access provides users to the ability to designate MPIDs as Primary or Supplemental for the purposes of market making. The deadline to make changes effective for the current trading day is 9:00 AM ET; all changes submitted after 9:00 AM will be effective for the following trading day.
 - The MFP also allows users to download a template sheet if they wish to make a bulk assignment change
 - Note: On Pearl Options and Sapphire Options, member firms can assign themselves in individual products using the MEO API; please see the latest <u>Pearl Options MEO</u> <u>Interface Specification</u> and <u>Sapphire Options MEO Interface Specification</u> for more details
- Symbols can be viewed and assignments can be edited in either default symbology format or NASDAQ symbology format

Order Search/Cancellation Page (Available for the Pearl Equities Exchange only)

- Users can query orders by a variety of details, including but not limited to, session, ClOrderID, and MPID
- Search results will provide users with the Last Action of the order and the Cancel Reason (if applicable)
- Searches can be made for the current trading day or previous trading days
- Write Access allows users to select and cancel open orders

Risk Configuration Page

MIAX Options Exchanges

- Users can view their firm's current Risk Protection Monitor ("RPM"), Aggregate Risk Manager ("ARM2"), and MIAX Order Monitor ("MOM") settings
- Write Access allows users to edit current MOM settings via the MFP (changes will be sent to the MIAX system, where they must be reviewed and accepted by the MIAX Trading Operations before being implemented for the following trading day)
- Note: For all 4 MIAX Options Exchanges, member firms can update ARM Settings and ARM2
- Underlying Configuration values using the MEI/MEO API; please see the latest Interface Specifications for more details
- A full list of settings available to be changed within this page is located in Appendix A

MIAX Pearl Equities Exchange

- Users can view their firm's current Cumulative Risk Metric ("CRM") settings and the current status of each session, group of sessions, MPID, or the entire firm
- Write Access allows users to edit the current CRM settings on a Firm, MPID, session group, or individual session level via the MFP which are effective immediately.
- Write Access also allows firms to initiate mass cancels, blocks, and resets on a session, MPID, or MPID Purge Group level basis which are effective immediately
- Write Access also allows firms to immediately reset any triggered Order Rate Metrics (i.e. Order Rate Check with Manual Reset, or Order Rate Check with Automatic Reset)
- Changes to Risk Protections can be made between the hours of 3 AM ET and 8 PM ET.
- A full list of settings available to be changed within this page is located in Appendix A; descriptions of each risk protection can be found within the Risk Protections Guide located in the Equities Exchange Functionality Page on the website.

Service Request Form Page

- Latest request forms are available for download
- For forms related to regulatory requests, such as trade adjustments or quoting relief, please see the <u>Options Regulatory Forms</u> or <u>Equities Regulatory Forms</u> pages on our website

Session Configuration Page

MIAX Options Exchanges

- Users can view their firm's current session details and session configurations for CTD, FOI, FXD, oFXD, and MEI/MEO sessions
- Write Access allows users to change any of the firm's various FOI, or MEI/MEO session notification settings via the MFP (changes will be sent to the MIAX system, where they must be accepted by MIAX Trading Operations and will be implemented for the following trading day

MIAX Pearl Equities Exchange

- Users can view their firm's current session details and session configurations for their CTD, FOI, FXD, oFXD, and MEO sessions
- Write Access allows users to change any FOI/MEO session specific risk settings via the MFP and any changes made will be effective immediately.
- Write Access for Pearl Equities also allows users to add or modify any Average Daily Volume, Restricted Security, or Regulation SHO Restricted Security lists per Session, which are effective immediately
- Members have the ability to update or edit the Locate Account Validation List
- Changes to Risk Protections can be made between the hours of 3 AM ET and 8 PM ET.
- A full list of settings available to be changed within this page is located in Appendix A; descriptions of each risk protection can be found within the Risk Protections Guide located in the Equities Exchange Functionality Page on the website.

MPID Configuration Page (Available for the Pearl Equities Exchange Only)

- Users can view their firm's current MPID Risk Configurations
- Write Access allows users to request changes for any of the firm's various risk settings for a given MPID via the MFP and any changes made will be effective immediately.
- Members have the ability to update or edit the Locate Account Validation List
- Write Access also allows users to add or modify any Average Daily Volume, Restricted Security, or Regulation SHO Restricted Security lists per MPID which are effective immediately
- Changes to Risk Protections can be made between the hours of 3 AM ET and 8 PM ET.
- A full list of settings available to be changed within this page is located in Appendix A; descriptions of each risk protection can be found within the Risk Protections Guide located in the Equities Exchange Functionality Page on the website.

Firm Configuration Page (Available for the Pearl Equities Exchange Only)

- Members have the ability to opt into a protection at the Firm Level that verifies the Locate Account specified on the member's Sell Short and Sell Short Exempt Orders.
 - To enable or disable this protection, please contact Trading Operations.
 - If the protection is enabled, Members have the ability to update the Locate Account Validation List; these changes are effective immediately.

Trade Search Page

- Users can query trades for their firm or a specific MPID by a variety of details, including but not limited to, underlying symbol, tradeID, and side
- Searches can be made for the current day's trading session or previous trading sessions
- For MIAX Options Exchanges only, Write Access allows users to make non-material corrections to trades for the current trading day, which then are subject to review from the MIAX Regulatory Team. Note: All corrections for a trade on the Pearl Equities Exchange must be submitted to the MIAX Regulatory Team via the appropriate <u>Pearl Equities</u> <u>Regulatory Form</u> on our website.
